# **MOVING ON**

We have had a busy and productive year at UUCC even though we are in the process of transition to a year of church life without a professional minister. Our budget is sustainable, capping spending invested assets at \$25,000., and acquiring a stable, long term rental with the Miracle Center Church that brings in \$14,400 a year. We are getting ready to take on the tasks of Lay Ministry. There is energy, vitality and creativity in our congregation. COM and folks from Council and Board worked at a weekend retreat (at Jeff Green's cottage in Michigan - thank you Jeff!) on detailed plans of how this will be done. You will hear more from the COM.

We can all be on the caravan moving forward to bring forth or vision "and a little bit more." It will be amazing what we can do working together. I see us strengthening our out-reach programs and exploring new areas.

Inside our building we have much to do to make us comfortable and to help each individual explore more deeply their spiritual path. All of our committees and growth teams know how important their work is to the daily life of our church. I want to share a few of my own reflections on being President of this congregation for the last four years. I have really come to endorse the "caravan concept of leadership." We are all in this together - past leaders and prophets before us, next generation coming behind - moving toward making our vision more and more of a reality. Our religious community is much more that a mechanical sum of its parts. We are always looking for new ways to do things that better suit our needs. (e.g. By Law change in 2005 - a new paradigm of governance for UUCC).

Two pathways of the heart from my Sufi studies come to mind; a president of the congregation has to strive "to widen their heart" to include more diversity--strive for a wider lens through which to see the world - "Al Wasi." Also follow the path of "Al Jami" to bring circles together, diverse people can work together toward a common/shared goal and we see this through social justice efforts, dream work, dances of universal peace. We need to be supportive of each other but also to be mentors to each other in a deliberate way. "Intentional Communication" is always the goal. Bringing "circles together" is one way to provide a space where all are heard. I hope we all adopt the attitude Marilyn Sewell portrayed in her movie, "Raw Faith", to paraphrase - "I do not know what is coming (from the universe) but I am available." I look forward to what my spiritual path will be and what opportunities for growth and service will occur.



# There will not be a FORUM for the months of June, July and August. Forum will resume Sept 9th.


## **UUCC Covenant Group Update**

The program has been running for about ten years. Covenant Groups (so named because their structure is based upon a covenant among the members) are common in many churches of the UU and other denominations. The members typically covenant to practice active listening, refrain from advice-giving, taking the group off-topic, or interrupting others. Such groups fall under the rubric of Small Group Ministry. Further information may be found in the Small Group Ministry Quarterly, a publication of the UU Small Group Ministry Network. (4303 Swarthmore Road, Durham, NC 27707). Their other publications include resource manuals on such topics as Social Justice, Small Group Ministry for All Ages, Facilitator Training and Development, etc.

### Dances of Universal Peace...



# **Green Sanctuary News - from Jodi Libretti**

Robin -- our Green Sanctuary Committee leader -- asked me to share information about a group of youth, led by 18-year-old Alec Loorz, that has brought a lawsuit against the federal government for failing to take action to reduce carbon emissions. Brilliant strategy!

The best way to explain the lawsuit is through excerpts from an open letter to President Obama written by the youth several days after the May 11th hearing in Washington, D.C., at which the defendants - the U.S. government plus the Nat'l Association of Manufacturers (which was allowed to join the case after it was filed) were asking for the case to be dismissed. The judge has not yet ruled. I hope this letter and the commitment of the youth will spark discussion and action on our part.

### Dear President Obama,

We are writing to request discussions with your Administration regarding our lawsuit, *Alec L. v. Lisa Jackson*...The Department of Justice is currently fighting this suit hand in hand with the fossil fuel industry. We would like to understand why your Administration is taking such a strong stand against us.

....Our generation knows that our lives and prosperity are at stake and that our children will live on a planet much different from the one we know today if immediate action is not taken...

Our lawsuit, written with support of the world's foremost climate scientists, is based on the Public Trust Doctrine. The Doctrine states that it is the government's responsibility to hold the natural resources needed for survival in trust for present and future generations. There is no more fundamental natural resource than our atmosphere. We seek an immediate order requiring the government to promptly implement a National Climate Recovery Plan, setting forth a comprehensive means for regulating harmful carbon emissions. Climate change is about science, not politics.

# [paragraph about the fight for civil rights and how people put their lives on the line for justice and for the benefit of future generations. A sustainable planet is a similar just & worthy cause.]

So far, the Department of Justice attorneys are fighting to prevent us from even making our case, calling the case too complex to try in a court of law. But, we believe you understood this complexity when you said, during a UN climate change summit, that "all of us will face doubts and difficulties...as we try to reach a lasting solution to the climate challenge. But I'm here today to say that difficulty is no excuse for complacency. Unease is no excuse for inaction."

...We simply want an opportunity to discuss how we and the government can work together rather than fight in court. We believe we are all on the same side.

- Campfire with stories on Saturday night



**Directions:** Take 94 East to 49. Follow the signs to the State Park. (Everyone will need to arrange their own rides and camping buddies).


